Honoring Laura Linzey by naming a building after her

On October 4, the Executive Council decided to change the name of the day care from Laura Linzey Day care to Absolute Day care per November 1, 2023. The day care was once named after Laura Linzey because the day care was at that moment located in the same building where Laura Linzey used to run the baby clinic. Because the day care has now changed location, has been expanded to include after–school care and Laura Linzey actually has no direct link with the day care, a new name has been chosen.

To permanently honour Laura Linzey for the significance she has had for Saba, it is now proposed to name the location where she used to work and where community development and public health are now located after her. This building will be named the Laura Linzey building.
