325/2023	Subject:	Transfer funds to Energy Subsidy to SEC 2nd Round
T	Summary:	Per decision letter 2022-0000118817, the Ministry of SZW has approved the transfer of funds to Saba government for the purpose of energy subsidy towards low-income households on Saba. Previoulsy, funds were transferred to the Saba Electric Company (SEC) for the allocation of 850 USD per household. Eighteen households were approved out of thirty households that applied. The Ministry of SZW had previously agreed to have this subsidy be raised to 1300 USD per household.

2	Summary:	The Public Entity would like to organize a week of sustainability which will tie into the upcoming earth day. We want the theme to be "A Sustainable Saba". This week of events will begin on April 17 th and end on April 22 nd with a large fair for the community. The schedule for this week is within the attachments to this proposal. As mentioned, we would like to organize a week of activities involving the youth and the general public so we can increase awareness of the 3Rs of recycling and also reinforce the idea of conservation on the island of Saba for Earth Day. The progress in recycling awareness has gone stagnant. It is visible on the sorting line at the landfill that people are not recycling as much as they once were. We want to bring together the different stakeholders on the island like OLS, SCS, SHS, The Lions Club, Sea and Learn, etc. so we can work together to preserve the Saban landscape further.

376/2023	Summary:	Since a few years now, the ministry of VWS requested that all three BES islands need to have a shelter and reporting point put in place, where survivors of domestic violence and child abuse can reside after having had to move out of their home due to having been exposed to a violent or unsafe domestic incident. Bonaire and Sint Eustatius currently have their shelter put in place and it is Saba's turn now to also show that we too value the
		importance of having a safe space where persons who are currently living in (psychologically) unhealthy living environments, can be given the opportunity to break free from their current living

		situation, and with professional guidance, can be provided the training and tools necessary to build themselves a new, mentally
17		healthier lifestyle. However, though small in size, Saba faces the same multifaceted problems seen with complex family cases that are also experienced in bigger countries. It's never just one component to tackle in order to help a family move on to a better lifestyle and way of thinking and thus, ideally would be to have a couple of shelters put in place. One for victims of domestic violence, one for troubled youth, one for toxic family relationships, etcetera. It goes without saying that having multiple shelters on Saba is unfeasible. To be able to provide to most forms of problematic causes for relocation while also be able to still provide the specific care, guidance, and support needed, tailored made to the specific family situation, we have come to the conclusion that the best way of making most use out of a shelter on Saba would be to have the shelter be multifunctional.
